COMPLETION OF ACQUISITION OF SILOAM HOSPITALS BUTON AND LIPPO PLAZA BUTON

1. Completion of Acquisition of Siloam Hospitals Buton and Lippo Plaza Buton

Further to the announcements by Bowsprit Capital Corporation Limited, in its capacity as manager of First Real Estate Investment Trust (“**First REIT**” and as manager of First REIT, the “**Manager**”):

- (i) dated 20 July 2017 in relation to the proposed acquisition of Siloam Hospitals Buton (“**SHBN**”) and Lippo Plaza Buton (“**LPB**”, together with SHBN, the “**Buton Property**” and the acquisition of the Buton Property, the “**Acquisition**”) from PT Andromeda Sakti; and
- (ii) dated 21 September 2017 in relation to the approval of unitholders of First REIT for the Acquisition,

the Manager is pleased to announce the completion of the Acquisition.

With the completion of the Acquisition, First REIT’s portfolio has been enlarged and now comprises 19 properties located in Indonesia, Singapore and South Korea.

2. Financing of the Acquisition

The total purchase consideration of S\$28.50 million for the Buton Property and value-added tax of S\$2.71 million was financed from internal cash and a drawdown from a bank loan obtained by First REIT.
